# Message from the Chair

2020 has been an exciting year for research at Bayside Health.

In early 2020, Bayside Health Service recruited an Academic Research Manager to help with building the research profile of Bayside Health. This first year of this role has been a great success with engagement and interest in research activities increasing across the hospital despite the challenges of COVID-19.

Bayside Health's Research Advisory Group met four times in 2020 and were able to discuss and approved 20 Site Specific Approvals for research at Redland Hospital. We were excited to see the number of approvals from Bayside-led research increase from 0 in 2019 to 6 in 2020. The Group



organised research events throughout the year including our second Research Grand Rounds and our Inaugural Research Showcase Day. The Research Showcase Day was attended by more than 100 people in-person and online and was a highly praised event by both Bayside staff and staff from other facilities. This event highlighted and encouraged local research and will become part of the annual research events calendar in 2021.

I would like to thank all members of the Research Advisory Group for their hard work and dedication throughout the year. We are proud of our progress this year and look forward to further work towards building research at Bayside Health in 2021.

#### **Academic Research Manager**

In early 2020, Bayside Health appointed Dr Elizabeth McCourt as the Academic Research Manager (0.8FTE) onsite. Dr McCourt is a pharmacist by background and completed her PhD at Queensland University of Technology in 2019. Her research interests lie in disaster management, public health, and medication management.

The aim of the Academic Research Manager role has been to provide onsite support and education for research to improve research culture and increase research capability and capacity. The Academic Research Manager has undertaken the following activities throughout the year:

- Providing guidance and advice on the ethics and governance process
- Assisting with developing research ideas
- Providing advice on appropriate research methods
- Assistance with data analysis
- Education and training on research related topics
- Proofreading and editing conference abstracts, paper submissions, and research reports
- · Assistance with developing dissemination plans and organising meetings with key stakeholders
- Secretarial support for Research Advisory Group
- Lead organiser for Inaugural Research Showcase Day
- Organising committee member for Research Grand Rounds

In 2020, the Research Manager has connected with more than 150 individuals at Bayside Health to answer research questions, assist with projects, and provide support for researchers. Towards the end of 2020 feedback on the Research Manager role was sought from those who had engaged in the service throughout the year. Satisfaction for the role was very high with clinicians overall rating their satisfaction as 4.9 out of 5 stars. Researchers provided overwhelmingly positive comments for the role and Dr McCourt's assistance with progressing work. Many comments focused on Dr McCourt's approachability, knowledge, and enthusiasm for research and how the role of Academic Research Manager removed barriers to research and made research more accessible at Bayside Health.

Funding for this position will continue in 2021.



#### **Ethical Approvals**


Support from the onsite Academic Research Manager in 2020 improved the initiation of Redland Led projects being submitted for ethics exemption, negligible risk review, and full HREC review.



### **Governance Approvals**

In 2020 there were 20 SSA approved for Bayside Health, this was consistent with the previous year. Despite numbers of SSAs remaining the same, there was a higher percentage of SSA applications that originated from Bayside Health Staff in 2020 compared to 2019. In 2019, 0% (n=0) SSA applications were from projects led by Bayside Health staff. In 2020, this figure increased in 30% (n=6).

With the Academic Research Manager providing support for the review, processing, and signing of SSA applications the average wait time from receipt of SSA from a researcher to the signed approval being sent back reduced from 14 business days in 2019 to 5 business days in 2020. At the start of 2020, the Research Advisory Groups aim was to have SSA applications processed within 7-10 business days.



#### **Grant Applications**

In 2019, there were no Redland-led applications submitted for Metro South's Research Support Scheme (MS RSS). In 2020, 7 Bayside-led applications were submitted for this scheme with two Bayside-led applications being successful and another under consideration for a second funding round (currently under review).

#### **Research Grand Rounds (March 2020)**

The first research event of the year for Bayside Health was the Research Grand Rounds hosted in March 2020. This was the second time this event was held at Redland Hospital. To encourage local research, the session was focused on research done by Bayside Health employees.

Dr. Joel ledema presented on 'The QLD LAM and its effects on utilisation and implications for medicines policy in Australia, an introduction to quasi-experimental research design'.

Coralie Stewart and Natasha Liddington presented on 'The Allied Health Brief Therapies Clinics collaborative project 2017-2019'.

The grand rounds were well attended and raised interest in research and the role of the Academic Research Manager.





### **Research Showcase Day (November 2020)**

The Inaugural Research Showcase Day was held on November 6<sup>th</sup> 2020 and was attended by more than 100 people online and in-person. This event was aimed at highlighting the work of emerging and novice researchers at Bayside Health and encouraging those who may be new to research to start a project. Many attendees commented on the sense of pride and inspiration they felt after seeing the great research projects that were taking place at Redland Hospital. #### **Emerging Researcher of the Year (December 2020)**

In 2020, a new award for the 'Emerging Researcher of the Year' was presented to a new researcher at Bayside Health who demonstrated an interest and dedication to research, made significant progress with a research project, and contributed to the growing research culture at Bayside Health. Dr Blanaid Canavan was the inaugural winner of this award. Throughout 2020, Blanaid demonstrated a passion for research and perseverance in undertaking her first ever research project. Dr. Canavan's project 'Effects of COVID-19 on medical admissions and ED presentations to a district general hospital' involved reviewing 400 patient records to collect data - most of this work was completed by Blanaid has demonstrated unwavering



enthusiasm for her work, presented her findings at the Bayside Research Showcase, and currently has her first manuscript for publication under review in a journal.

#### **Future directions for Research at Bayside Health in 2021**

While 2020 brought some unexpected challenges, we have seen research culture and capacity at Bayside Health grow. We have seen increases in numbers of ethics applications, SSA applications, publications, and grant applications in 2020, we strive to meet and improve on this in 2021.

The continuation of the Academic Research Manager role for 2021 means that we can continue to build research capability and capacity. In 2021 we want to have more frequent and structured education and training (something that was challenging in 2020 due to COVID-19). We will continue to have research events hosted by the Research Advisory Group such as Grand Rounds (March 2021) and a second Research Showcase Day (November 2021).

With new Research Advisory Group representation in 2021, we hope to continue to build upon the research culture at Bayside Health and with all departments within the Hospital and beyond. We will also be focusing on further developing and embedding sustainability into the research capacity that has been developed at Bayside Health.

We believe 2021 will be Bayside Health Service's best research year yet.
